

RELEASE AND WAIVER OF LIABILITY AGREEMENT

A. Waiver of Liability Relating to Coronavirus/COVID-19

The novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. COVID-19 is reported to be extremely contagious. The state of medical knowledge is evolving, but the virus is believed to spread from person-to-person contact and/or by contact with contaminated surfaces and objects, and even possibly in the air. People reportedly can be infected and show no symptoms and therefore spread the disease. The exact methods of spread and contraction are unknown, and there is no known treatment, cure, or vaccine for COVID-19. Evidence has shown that COVID-19 can cause serious and potentially life-threatening illness and even death.

Gujarati Society of Central Florida (hereafter "GSCFL") cannot prevent you from becoming exposed to, contracting, or spreading COVID-19 while utilizing the GSCFL's services or premises. The GSCFL has instituted social and physical distancing measures, however, it is not possible to prevent against the presence of the disease. Therefore, if you choose to utilize the GSCFL's services and/or enter onto the GSCFL's premises you may be exposing yourself to and/or increasing your risk of contracting or spreading COVID-19.

ASSUMPTION OF RISK: I have read and understood the above warning concerning COVID-19. I hereby choose to accept the risk of contracting COVID-19 for myself in order to utilize the GSCFL's services and enter the GSCFL's premises. These services are of such value to me that I accept the risk of being exposed to, contracting, and/or spreading COVID-19 in order to utilize the GSCFL's services and premises in person.

WAIVER OF LAWSUIT/LIABILITY: I hereby forever release and waive my right to bring suit against the GSCFL and its officers, directors, managers, officials, agents, employees, or other representatives in connection with exposure, infection, and/or spread of COVID-19 related to utilizing the GSCFL's services and premises. I understand that this waiver means I give up my right to bring any claims including for personal injuries, death, disease or property losses, or any other loss, including but not limited to claims of negligence and give up any claim I may have to seek damages, whether known or unknown, foreseen or unforeseen.

B. RELEASE AND WAIVER OF LIABILITY AGREEMENT for Gujarati Society of Central Florida, Orlando Cricket

I acknowledge that I have voluntarily applied to participate in activities of playing cricket organized by Gujarati Society of Central Florida HARD TENNIS BALL CRICKET TOURNAMENT 2021.

I AM AWARE THAT THESE ACTIVITIES ARE HAZARDOUS AND THAT I COULD BE SERIOUSLY INJURED. I AM VOLUNTARILY PARTICIPATING IN THESE ACTIVITIES WITH KNOWLEDGE OF THE DANGER INVOLVED AND AGREE TO ASSUME ANY AND ALL RISKS OF BODILY INJURY, DEATH OR PROPERTY DAMAGE, WHETHER THOSE RISKS ARE KNOWN OR UNKNOWN.

I acknowledge that I will be responsible bringing my own cricket playing protective equipment's and wear at all the time while playing all Cricket protective equipment including but not limited to batting gloves, keeping gloves, cricket spikes shoes, helmets, sun-glasses and support cup (L Guard).

As consideration for being permitted by the Gujarati Society of Central Florida (GSCFL), and its representatives to participate in these activities and use the ground and facilities, I forever release the Gujarati Society of Central Florida's Members, President, Executive Committee, Volunteers and Representatives (collectively "Releases") from any and all actions, claims, or demands that I, my assignees, heirs, distributees, guardians, next of kin, spouse and legal representatives now have, or may have in the future, for injury, or property damage, related to (i) my participation in these activities, (ii) the negligence or other acts, whether directly connected to these activities or not, and however caused, by any Releases, or (iii) the condition of the premises where these activities occur, whether or not I am then participating in the activities. I also agree that I, my assignees, heirs, distributees, guardians, next of kin, spouse and legal

representatives will not make a claim against, sue, or attach the property of any Releases in connection with any of the matters covered by the foregoing release.

I HAVE CAREFULLY READ THIS AGREEMENT AND FULLY UNDERSTAND THE CONTENT. I AM AWARE THAT THIS IS A RELEASE OF LIABILITY AND A CONTRACT BETWEEN MY SELF AND GSCFL, AND SIGN IT OF MY OWN FREE WILL.

C. CHOICE OF LAW: I understand and agree that the law of the State of Florida will apply to this contract. Venue shall be a court in Orlando, Florida.

I HAVE CAREFULLY READ AND FULLY UNDERSTAND ALL PROVISIONS OF THIS RELEASE, AND FREELY AND KNOWINGLY ASSUME THE RISK AND WAIVE MY RIGHTS CONCERNING LIABILITY AS DESCRIBED ABOVE.
